

Official Rules for 'Go To the Big E For Free' Sweepstakes

1. Eligibility: The Go to the Big E For Free Sweepstakes is open only to those who like and share the post found here: <https://www.facebook.com/pg/MMFCU/posts/> and who are 18 years of age or older as of the date of entry. The Go to the Big E For Free Sweepstakes is only open to legal residents of the United States, and is void where prohibited by law. Employees of MassMutual Federal Credit Union immediate family members and/or those living in the same household of Employees are not eligible to participate The Go to the Big E For Free Sweepstakes. The Go to the Big E For Free Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. The Go to The Big E For Free Sweepstakes Period: All online entries will be accepted online starting on Sunday, September 8th, 2019 at 2:00 P.M. EST and ending Thursday, September 12th, 2019 at 11:59 P.M. EST. All online entries must be received by Thursday, September 12th, 2019 at 11:59 P.M. EST.

4. How to Enter: The Go to the Big E For Free Sweepstakes must be entered by liking and sharing the post found here: <https://www.facebook.com/pg/MMFCU/posts/>. The entry must fulfill all requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of MassMutual Federal Credit Union.

5. Prizes: The Winners of The Go to the Big E For Free Sweepstakes will receive 2 adult tickets to the Big E, valued around \$15 each. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by MassMutual Federal Credit Union. No cash or other prize substitution shall be permitted except at MassMutual Federal Credit Union's discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. If Winner cannot be contacted, is ineligible, fails to claim the prize within 2 days from the time award notification was sent, the prize may be forfeited and an alternate Winner selected.
